COMPONENT 8: HEALTH AND SAFETY

COURSE OVERVIEW

This course covers the steps to help child care providers prepare for incidents to ensure the safety of the children at their site. Child care providers must have plans and procedures to keep children safe from everyday hazards and to respond and recover when an emergency happens.

The goal of this course is to provide child care providers, with businesses of all sizes, and with responsibility for children of all ages, with the knowledge and tools to analyze the hazards and threats at their site, to develop a plan to address these hazards and threats, and to implement processes to update and practice the emergency plan. The topics addressed in this course include: knowing your hazards, developing a plan, and testing and updating your plan.

LEARNING OBJECTIVES

At the completion of this course you should be able to:

- Describe why it is important to be prepared
- Identify hazards and threats that impact your child care site
- Describe how to prevent or mitigate the impact of likely and high-consequence hazards and threats
- Describe procedures for when an emergency occurs
- Identify how your child care site will recover from an emergency
- Describe how to develop and maintain your plan
- Describe how you will communicate, train, and practice preparedness procedures
- Identify the emergency preparedness information you will share with your community
- Describe when to update your plan

INSTRUCTIONS

Part 1: Knowing Your Hazards

Part 1.1

- a. Create a list of three ways you might evacuate several children at one time, including infants, toddlers, and children with access and functional needs.
- b. Identify what you already have in place.
- c. Identify what you would need to be able to carry this out.

Part 1.2

- d. Identify three hazards that may affect your child care facility.
- e. Identify three actions you can take to reduce the risk of each hazard.

Part 2: Developing a Plan

- 4. View the presentation online through your IdahoSTARS provider account.
- 5. Follow the FEMA Student Manual with the presentation.
- 6. Activity
 - a. Review the list of planning and preparedness issues in the Student Manual: Child Contact Information; Emergency Contact Information; Documented Procedures; and Emergency Supplies.
 - b. Determine if you have a process to address each issue at your child care site.
 - c. List any issues that you may need to address.
 - 7. Review the FEMA Sample Childcare Emergency Action Plan, or the FEMA Sample Childcare Emergency Operations Plan (depending on the size of the program you work at). Both are available for download.
 - 8. Activity
 - a. Answer the following questions:
 - i. What processes and procedures are you missing?
 - ii. What do you need to add?
 - iii. What processes and procedures do you have in place?
 - iv. How can you improve existing processes and procedures?



Part 3: Testing and Updating Your Plan

- 10. Follow the FEMA Student Manual with the presentation.
- 11. Complete Activity
 - a. Develop a set of simple instructions for a type of drill.
 - b. Share the instructions you created with a coworker or colleague.
