



How to Complete the Live Training Evaluation in RISE

This is a guide on how to complete a training evaluation for training you registered for in RISE and attended in-person or over live-webinar.

Please Note: To receive the training hours on your PDRecord, you must be marked as attended on the roster, as paid (*with an IdahoSTARS Training Scholarship, out of pocket, or the training is free*), your training evaluation is completed within 30 days of the training, and the roster has been submitted by the trainer.

1. The evaluation is available to complete at the end of the training.
2. You **MUST** complete the training evaluation within 30 days to receive training hours.
3. If the evaluation expires, the course must be retaken to receive training hours.
4. To get to your training evaluation, on your dashboard in your RISE account, find and click the **“To Do”** tab or the **“My Registrations and Evaluations”** tab under Quick Links. Once you click one of the tabs, you will be taken to your evaluation.
